# **2018 Annual Report**

### **Membership Composition and Diversity**

The 2018 American Psychological Association (APA) Commission on Accreditation (CoA) was led by the following Commissioners: Stephen R. McCutcheon, PhD, CoA Chair; David A. Smith, PhD, ABPP, Associate Chair for Program Review; and Cindy Juntunen, PhD, Associate Chair for Quality Assurance. The CoA is comprised of 32 members who represent a balance of academic programs and institutions, practitioners of the profession, and the publics served by psychology, higher education, and accreditation. Appendix A presents a brief profile of each individual Commissioner and the group that submitted their nomination to the CoA.

In terms of individual and cultural / group diversity, representation on the 2018 CoA included half (50.0%) of the Commissioners identifying as female and 12.5% as a racial or ethnic minority. Geographic diversity was noted with 21 different states of residence represented by members of the Commission. Although other forms of diversity are present among the Commissioners, this information is not collected in a standard fashion and is therefore not provided.

In terms of diversity within the discipline, psychologists serving on the CoA represented 25 divisions of the APA; the proportional representation of all APA divisions for the 2018 Commission is 44.6%. APA Fellow status was held by 31.0% (9/29) of the psychologist Commissioners. Also, among the psychologists on the Commission, 17.2% (5/29) have reportedly attained certification by the American Board of Professional Psychology (ABPP).

### **CoA Meeting Structure**

The CoA met on the following dates during the calendar year 2018: February 7 (new member orientation); February 8-11 (policy); April 11-15 (program review and policy); July 18-22 (program review and policy); and October 24-28 (program review and policy). Commissioners were responsible for conducting program reviews and participating in both a “policy panel” and a “work group.” The policy panels and work groups serve as task forces for particular types of policy and procedural issues that the Commission elects to address throughout the course of the year. In 2018, the three policy panels were: doctoral, internship, and postdoctoral; and, the four work groups were: communication, complaints, research, and training.

### **Program Review Summary**

During the 2018 program review meetings, the CoA reviewed submissions and made accreditation decisions on 301 programs. The following table provides a listing of the different accreditation program review decisions made by the CoA in 2018:

\* Note. Four (4) of the reviews occurred under the *Guidelines & Principles of Accreditation* (G&P), while the other 297 reviews were conducted under the *Standards of Accreditation for Health Service Psychology* (SoA).

In addition to conducting these full reviews, six (6) programs were reviewed and granted the non-accredited, “intent to apply” status in 2018 (previously termed “eligible” status). Plus, the CoA granted new or continuation requests for “accredited, inactive” status that were received from 23 programs, and accepted the voluntary withdrawal of accreditation from 3 accredited programs. The Commission also evaluated numerous interim reports (N=216) submitted by accredited programs. Lastly, the CoA conducted a review data submitted by accredited doctoral programs in the Annual Report Online (ARO). This review examines specific information against threshold values, as is prescribed in Implementing Regulations D. 4-7 b and c. Thirty-six (36) programs were noted to have submitted data that was incongruent with the threshold value and therefore subject to additional reporting to demonstrate consistency with the SoA. As part of the ARO, the Commission also examined program’s reporting change in fiscal status, as prescribed by accreditation standards and regulations.

At the conclusion of 2018, there were a total of 1,180 accredited programs. A detailed breakdown of the numbers and types of accredited programs is provided in Table 2 on page 3. Appendix B presents the growth in the number of accredited programs by decade between 1948 and 2018.

Throughout the year, the Office of Program Consultation and Accreditation (OPCA) staff provided logistic, clerical, financial, and administrative support to the Commission. For example, OPCA staff completed preliminary or administrative reviews of self-studies submitted by 80 applicant programs and 154 accredited programs seeking continued accreditation. OPCA staff also coordinated the 212 site visits made to programs during 2018. Lastly, staff provided consultative guidance to programs and constituent groups on accreditation matters.

**Policy Changes and Public Comment**

During 2018, the CoA dedicated time at each of their meetings to creating policy and procedures for the continued transition and implementation of the SoA. (Approved in February 2015, the SoA became effective on January 1, 2017.) In 2018, a total of 13 Implementing Regulations (IR) were reviewed and modified or prepared by, the CoA policy groups. These IRs were then published for a period of public comment and, further review by the CoA, led to revisions in 8 IRs. The CoA continues to examine policies and procedures, and in so doing, receives comments from the publics served by accreditation.

**Communications Work Group**

Among a number of activities, the CoA Communications work group prepared content for four issues of the *CoA Update*. The *CoA Update* is published on the APA accreditation [website](#).

## Complaints Work Group

The Complaints work group received, reviewed and made recommendation on 11 complaints that were filed against accredited programs. The CoA reviewed, discussed and decided on the recommendations in these matters.

## Training Work Group

The Commission conducted workshops at multiple training council meetings and at the APA Convention. These workshops were focused on the training of site visitors and providing information on how to complete a self-study. The number of attendees at the 2018 site visitor workshops was 229, while there were 249 attendees at the self-study workshops. In addition, the CoA, with the support of staff in the OPCA, continued developing a series of online learning modules. These online modules are focused on the SoA and are to be used by programs completing a self-study or for those with questions about the SoA. These modules are currently available on the OPCA [website](#).

## Research Work Group

With support from OPCA staff, the CoA conducted research activities in 2018. Some activities included, an analysis of program outcomes in accord with the data thresholds established to monitor student achievement and compliance with accreditation standards, as noted in the program review summary. In addition, the research work group reviewed and made recommendations to the CoA, to approve two requests for use of accreditation data in accord with procedures (i.e., IR E.1-3[a] *Use of Data and Research Personnel Resources*). *These requests allowed for the release of the results from specific analyses completed by the CoA / OPCA and are available on the OPCA [website](#).*

## USDE Recognition

The U.S. Department of Education (USDE) has recognized the APA as a programmatic accrediting agency, with accreditation actions completed by the CoA. As part of the recognition process, a petition to have its recognition by the USDE renewed, was submitted in 2016. The petition was continued, with compliance issues noted. The compliance issues were subject to a report in 2018. The National Advisory Committee on Institutional Quality and Integrity (NACIQI) recommended, and the USDE Undersecretary of Education concurred, that the APA CoA was compliant with the issues noted. Correspondence from the Undersecretary noting recognition was received in September 2018. In accordance with regulations, the APA CoA will submit their next report in three years (2021).

## CHEA Recognition

The CoA is recognized as an accrediting body by the Council for Higher Education Accreditation (CHEA). The CoA submitted an Interim Report in December 2018. This report will be reviewed in 2019.
